Terminal Handling Charges (THC)/LCL Charges (CPA Tariff Item No-4.1) and all other charges for Containers will be included in the freight. Importer will not pay any other charges to the agent in the destination. For Export Container the same procedure will be followed.

This circular is hereby issued with the approval of the competent authority and shall come into effect from 20th May, 2007.

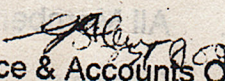
