CIRCULAR NO. 06 /97

Sub:-Restricting the maximum Gross weight of 20' and 40' Container to be handled at Chittagong Port.

It is notified for information of and necessary action by all concerned that in line with ISO Ratings 20' and 40' container with a maximum Gross weight of 24,000 Kgs. and 30,480 Kgs. respectively shall be accepted at the Port of Chittagong.

But in the event of any Shipping Line/MLO bringing any container laden with cargo out-weighting the above ISO prescribed weight limits, Chittagong Port Authority may not supply equipments for handling such containers. In such a situation, concerned Shipping Agent/MLO has to make necessary arrangement of their own for handling/transportation of such over-weight containers at their own cost, risk and responsibility and CPA's prior permission should be obtained in advance of arrival of such containers.

Any one/Agency failing to comply with the above shall be liable for any consequence arising out of any mishap in course of handling and transportation of such non-standard Containers.

This is in supersession of all previous orders including Borth Manager/CPA's Circular No.16/93 dated 09.9.93, comes into force w.e.f. 1st March, 1997 and shall be applicable for Dhaka ICD also.
